【For Immediate Release】**BAGUIO WAS AWARDED A SERVICE CONTRACT FROM THE CHP IN
RELATION TO THE CLINICAL WASTE COLLECTION AND DISPOSAL SERVICES
UNDER COVID-19 VACCINATION PROGRAMME**

(17th March 2021 — Hong Kong) Baguio Waste Management & Recycling Limited, a wholly owned subsidiary of Baguio Green Group Limited (“Baguio” or the “Group”, Stock Code: 1397.HK) is pleased to announce that in recognition of the Group’s capability for collecting clinical waste, the Group was awarded a service contract (the “CHP Contract”) from the Centre for Health Protection (the “CHP”) of the Department of Health of Hong Kong in relation to the clinical waste collection and disposal services under Covid-19 Vaccination Programme in February 2021, pursuant to which, the Group will collect the clinical waste at the Community Vaccination Centres established in the 18 districts in Hong Kong. The Group believes that the recent increasing market demand for clinical waste collection services mainly results from the successive introduction of various pandemic prevention and control measures against Coronavirus Infectious Disease 2019 (COVID-19) in Hong Kong, such as the opening of quarantine centres in Lei Yue Mun Park & Holiday Village and the implementation of Universal Community Testing Programme with voluntary participation. All of these measures have led to an increase in the collection of clinical waste and an increase in the demand for cleaning services of related facilities.

Given the keen market demand for clinical waste collection services over the past year in line with the concerted efforts of all walks of life in Hong Kong to fight against COVID-19, Baguio has been actively expanding the scope of its clinical waste collection services while encouraging public participation in the collection of clinical waste. In addition to serving a number of public and private clinical institutions in Hong Kong, including Western and Chinese medical centres, private clinics, beauty parlors, examination organizations and laboratories, the Group also expanded its services to customers in other areas, including well-known world-class horse racing institutions and local residential care homes for the elderly (RCHEs), nursing homes, as well as public and private organizations ranging from primary and secondary school and early childhood educational institutions, to social welfare organizations. It highlights the fact that, as one of only seven licensed clinical waste collectors in Hong Kong since it obtained the clinical waste collection license in 2014 and started to provide related clinical waste collection services, it has spared no effort to expand the scope of clinical waste collection services.
